# 2014 EHRC Conference and General Assembly in Gijon, Spain

At the 2014 EHRC Conference and General Assembly in Gijon, Spain, the EHRC member Countries elected a new EHRC Committee, comprising of Keld Christensen (Denmark), Denis Bieri (France), Laszlo Bognar (Hungary), Egbert Feddersen (Germany), Sofia Alday (Spain), Anna Siekierska (Poland), Giorgio Burchiellaro (Italy), Jos Buiting (Netherlands) and Michael Parkinson (UK) to sit on the EHRC Committee. Due to a personnel change Michael has left Holstein UK, however Holstein UK have a new CEO, Richard Jones who has taken his place on the EHRC Committee. The Committee welcomed Richard to their group and look forward to working with him. The EHRC Committee thanks Michael for all his work on the WHFF Type Harmonization Working group and when sitting on the EHRC Committee.

Joseph Crettenand (Switzerland) retired from the EHRC Committee and as chairman of the EHRC European Championship working group at the 2014 EHRC Conference. **EHRC European Championship Working Group** under the Chairmanship of Laszlo Bognar (Hungary) met twice in 2015 in preparation for the 2016 European Show.

The group has welcomed the advice from Pascal Monteleone who organised the last show in Fribourg, Switzerland.

A new European Showing Terms of Reference is being produced, and will be available soon on the EHRC website.

The EHRC Judges Panel Working Group has had a very productive year. We have had three meetings under the Chairmanship of Keld Christensen (Denmark).

EHRC Judging Terms of Reference (TOR) have been re-written into one document, incorporating TOR for the Working Group, the Judges Panel, the Harmonisation and Judges Panel Workshop and the Judging School. These TOR may be found on the EHRC website under a new section in 'Documents'.

Following the November EHRC committee meeting in Paris it was announced that the Chairman, Keld Christensen is to step down from the WG and from the EHRC Committee at the end of March 2016 when he retires from Danish

Holstein Association. Egbert Feddersen (Germany) was elected by the EHRC Committee to replace Keld. It was also decide that a new member, Soren Christensen (Denmark) was to join the committee to replace John Gribbon (UK) who is also retiring from the WG. The EHRC Committee would like to thank John and Keld for the hard work and time they have given to EHRC and to the Judges Panel WG over the past years.
